# 1. Call to order

### 7. Sub-committee reports

- a. Poage Park
  - City staff will address concerns about stickers in grass at volleyball court.
- b. Whitehall Park
  - Report included some suggestions about use of the newly-cleared space that was occupied by the old playground equipment.
- c. Activity Park
  - Report included brief discussion about what is allowed by the Corps of Engineers.
- d. Lakeside Park
  - Concerns were discussed about the health and safety of trees at the water line and complaints about the disc golf course. City staff will evaluate the trees, and indicate that the disc golf course is part of a future Capital Outlay proposal.
- e. Woodway Family Center
  Board members are excited about the new activities being advertised. The new center should be opening within the next couple of months.
