# **CALL MEETING TO ORDER**

Mayor Qourzal called the meeting to order at 5:31 p.m.

#### **INVOCATION AND PLEDGE**

1. INVOCATION

Councilmember Williams provided the invocation.

2. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the United States Flag was recited in unity

#### **PRESENTATIONS**

3. QUARTERLY PRESENTATION – FINANCE DEPARTMENT (REGARDING GENERAL FUND REVENUES AND EXPENSES, UTILITY FUND REVENUES AND EXPENSES, AND TOURISM FUND REVENUES AND EXPENSES THROUGH DECEMBER 31, 2022)

Director Brenda Hernandez, explained changes that she had made to the report before presenting the quarterly report for the Finance Department. The report covered the first quarter of FY 2022/2023, beginning October 1, 2022 and ending December 31, 2022. Ms. Hernandez discussed general fund revenues and expenditures, utility fund revenues and expenditures, water system revenues and expenditures. Ms.

Hernandez answered questions.

4. RACIAL PROFILING REPORT – PUBLIC SAFETY DEPARTMENT (COMPLETE ANALYSIS OF THE RACIAL PROFILING DATA FOR 2022 AS REQUIRED BY ARTICLE 2.132(7) OF THE TEXAS CODE OF CRIMINAL PROCEDURE)

Assistant Chief El-Halabi stated that this is the required report of the data collected under Article 2.132(7) of the Texas Code of Criminal Procedure.

Some high points of this analysis are:

- The statistical analysis of the collected data reveals there is no conclusive indication of the occurrence of racial profiling by the department. All traffic stops, arrests, and citations by race and ethnicity are in line with the population make up of McLennan County.
- The Department is in full compliance with state law and how we report annually.
- The Department received one citizen complaint in 2022 alleging racial profiling which was found to be unfounded after internal investigation.

He also provided a breakdown of percentages regarding gender, race or ethnicity, types of stops, etc. We conducted 695 searches and a breakdown of percentages was provided as to whether the searches were by consent, probable cause and reasonable suspicion. Out of those 695 searches, we see that the majority did result in contraband being discovered.

22% of our traffic stops result in citations and the rest result in written warnings. Our main concern is to get people to slow down with 3.6% resulting in arrest, which is a total of 7,021 stops. These arrests were based on primarily the Penal Code violation and outstanding warrants. We had 3 incidents where physical force was used with bodily injury and 7018 where no force was used.

A copy of the report was provided in the agenda packet.

Questions were answered.

5. COMPREHENSIVE MASTER PLAN – ADMINISTRATION DEPARTMENT (UPDATE ON PROGRESS CONCERNING WORK PERFORMED BY KIMLEY-HORN AND ASSOCIATES, INC. FOR CONSULTING AND URBAN PLANNING OF THE HIGHWAY 84 OVERLAY DISTRICT ALONG WITH UPDATING THE CITY'S COMPREHENSIVE MASTER PLAN)

Dr. Caballero provided the following update: The City Manager and Dr. Caballero met with Kimley-Horn on January 18<sup>th</sup> to kick the project off. There are eleven tasks that go with this process broken down into two parts. 1) Comprehensive Master Plan over the whole city and 2) Highway 84 Corridor.

In this first meeting, we discussed the Comprehensive Master Plan and having to project a timeline for

collecting data from January through May. We discussed the project, project scope, consultant communication with us and how to receive data from the City. We also discussed data collection and mapping for the Overlay District. Kimley-Horn will capture a collectively agreed upon vision of framework for the district. The final strategy will include the following segments: the history and background of Highway 84, the public engagement summary, existing conditions analysis, district character, framework, land use, zoning recommendations, policies, implementation strategies and action items.

Finally, it is very important to have community engagement. We talked about providing a map of dates, in-person meetings, and on-line presence on their website to collect information and provide input.
