CALL MEETING TO ORDER

Mayor Qourzal called the meeting to order at 5:30 p.m.

INVOCATION AND PLEDGE

1. INVOCATION

Councilmember Williams provided the invocation.

2. PLEDGE OF ALLEGIANCE

PRESENTATIONS

3. QUARTERLY PRESENTATION – COMMUNITY SERVICES AND DEVELOPMENT'S REPORT REGARDING PROGRESS ON NEW CONSTRUCTION, ANTICIPATED COMPLETION DATES AND THE ISSUANCE OF CERTIFICATES OF OCCUPANCY, AND INSPECTION STATISTICS FOR THE SECOND QUARTER OF FY 2023

Assistant Community Services and Development Director John Norman presented the Community Services and Development's quarterly presentation covering January 2023 through March 2023. He reviewed several photographs provided on a PowerPoint presentation of current residential development around the City, along with several commercial projects. Quarterly figures were attached for purposes of inspections. There were no questions.

Brenda Hernandez, Finance Director, presented the quarterly report for the Finance Department. She stated that we are halfway through the fiscal year which ended March 31, 2023. Ms. Hernandez discussed the general fund revenues and expenses, utility fund revenues and expenses, and tourism fund revenues and expenses.

ITEMS FOR INDIVIDUAL DISCUSSION, CONSIDERATION AND/OR ACTION

5. DISCUSSION AND CONSIDER ACTION ON ACCEPTANCE OF FY 2021-2022 ANNUAL AUDIT PROVIDED BY BROOKS WATSON & CO.

Mayor Qourzal called for a motion to discuss. Councilmember Russell moved to open this item for discussion and Councilmember Gilman seconded.

Dr. Oubre stated that Louis Breedlove who is with Brook Watson & Co, who conducted the audit. This is the first year for them to conduct the City's audit. The audit committee met March 24, 2023 to review the audit in detail.

Mr. Breedlove provided that this is the first year to work with the City of Woodway. He said it was a very smooth transition and the City has a great staff. He provided a PowerPoint presentation with an overview of the audit process. He presented informational slides on various aspects of the annual audit. The City received an unmodified opinion which is often referred to as a clean opinion. This is the highest level of assurance that auditors are able to provide.

Questions were answered.

Councilmember Russell moved to accept the 2021-2022 annual audit prepared by Brooks Watson & Co. based on the review and recommendation of the City Council Audit/Investment Committee, Councilmember Gilman seconded, and the motion passed unanimously.

6. CITY MANAGER TO EXECUTE ANY DOCUMENTS IN CONNECTION THEREWITH

Mayor Qourzal called for a motion to discuss. Councilmember Russell moved to open this item for discussion and Councilmember Cook seconded.

Dr. Oubre provided that we currently do business with Astound, formerly Grande Communications. This is a new service agreement due to the age of the old one. We will be changing phone systems due to our current system being outdated. We will also be expanding our broadband which is currently 100 mb by 100 mb to 1000 mb by 1000 mb which will help in retention and uploading of body cameras, video cameras, etc. The monthly cost will increase by \$932.14.

Questions were answered.

Councilmember Williams moved to authorize an expenditure in the total amount of \$2,372.14 monthly to Astound for the lease of their hosted cloud-based phone system. Councilmember Cook seconded, and the motion passed unanimously.

7. Dr. Oubre provided that Mr. Waters is the applicant and the property owner. The reason this is before you is due to the fact that none of the streets in Rainbow Lake are dedicated City streets. When someone files a replat and we don't recognize them as fronting any streets, they have to ask for a variance to get this final replat approved. This went before the Planning & Zoning Commission on April 11, 2023 and was approved with the variance request.

Councilmember Gilman moved to approve the final replat of Lots 72-73, Block A, Rainbow Lake Subdivision to the City of Woodway, McLennan County, Texas, being all of that called 0.580 acre tract of land, described in a deed to Douglas M. Councilmember Gilman seconded, the motion passed with a six to one vote, with Mayor Pro Tem Mercer voting against the process and not the applicant.
