The Woodway City Council met in a regular meeting in the Donald J. Baker Council Chambers at Woodway City Hall, 922 Estates Drive, Woodway, Texas, on Monday, May 8, 2023, at 5:30 p.m. The following individuals were in attendance:

CALL MEETING TO ORDER

Mayor Qourzal called the meeting to order at 5:30 p.m.

INVOCATION AND PLEDGE

1. INVOCATION

Mayor Qourzal provided the invocation.

2. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the United States Flag was recited in unity

PRESENTATIONS

3. RECOGNITION OF WOODWAY YOUTH COMMISSION MEMBERS AND RECOGNITION OF GRADUATING SENIORS

Mayor Qourzal thanked Corporal Isbell for his service and working with the Youth Commission. He also addressed the Youth Commission to let them know how much they were appreciated for giving back to their community. On behalf of everyone at the City of Woodway – Thank you.

Councilmember Williams is the liaison to the Youth Commission. He provided a few comments regarding his history in working in government for more than twenty years. He also teaches federal and state government at MCC. They are finding out in life that there is nothing that government doesn't touch in life either directly or indirectly. The more one participates, the more you understand and get involved. He appreciates their service and knows that they will do great things.

4. PRESENTATION TO THE HEART OF TEXAS 100 CLUB

Corporal Isbell stated that the Bound for the Brave Race is the one fund raiser they have every year. All the proceeds raised go to the Texas Police Chiefs Association and the Heart of Texas 100 Club to help with the benefit packages they provide for officers and first responders that are either seriously injured or killed in the line of duty. This is a benefit that they feel very strongly and passionate about. The proceeds from this event are split in half. One half was presented at the Texas Police Chiefs Conference and a check in the amount of \$2,130.00 is being presented at this meeting to the Heart of Texas 100 Club.

ITEMS FOR INDIVIDUAL DISCUSSION, CONSIDERATION AND/OR ACTION

5. DISCUSSION AND ACTION ON RESOLUTION R-23-09, TO CONSIDER WAIVER OF PENALTIES AND INTEREST ON DELINQUENT AD VALOREM TAXES PURSUANT TO TEXAS TAX CODE § 33.011 FOR THOMAS PROVENCE DUE TO THE CLOSURE OF CITY, COUNTY, AND FEDERAL OFFICES JANUARY 31, 2023 AND FEBRUARY 1, 2023 DUE TO SEVERE WEATHER IN THE REGION

Mayor Qourzal called for a motion to discuss. Councilmember Russell moved to open this item for discussion and Councilmember Avant seconded.

Dr. Oubre stated that a similar item was heard at a previous meeting. Mr. Thomas Provence is the applicant and is here to answer any questions you might have. Due to the inclement weather between January 31st and February 1st, this caused some taxes to be delinquent. The tax code gives consideration for an item which occurred like this where offices were closed due to weather. Mr. Provence is here seeking credit for his penalty and interest of \$26.74.

Mr. Provence addressed the City Council and stated that he brought an Affidavit swearing to the fact that the taxes were mailed on January 31st and it is notarized. There are two properties with one being in Waco. This was also sent to Judge Scott Felton's office and received a waiver from the County. Although he dropped it off on January 31st, it was sent to Dallas and not dated until February 2nd.

Mayor Qourzal stated that the City Attorney would have a few questions of Mr. Provence, however, Mr. Shaw stated that he had reviewed the Affidavit before the meeting got started and it addresses everything that he would have asked Mr. Provence and is sufficient under the tax code.

Councilmember Russell moved to adopt Resolution R-23-09, waiving the penalties and interest per Texas Tax Code Chapter §33.011 for applicant, Thomas Provence. Councilmember Gilman seconded and the motion passed unanimously by the Councilmembers present.
