Tom Ray of Hicks Ray Associates provided a PowerPoint presentation on the background of Hicks Ray Associates and what they do. He also answered questions.

Councilmember Gilman moved to enter into an agreement with Hicks Ray Associates, to provide professional services by assisting the City of Woodway in acquiring federal grants for public works projects in an amount not to exceed \$42,000.00, and authorizing the City Manager to execute all documents in connection therewith. Councilmember Russell moved to award a contract in response to Bid #23-09, for 12-inch water line improvements to Kasparian Underground, LLC d/b/a H&B Contractors, the lowest responsible bidder, in an amount not to exceed \$943,581.60, and authorize the City Manager to execute any documents in connection therewith. Councilmember Gilman seconded, and the motion passed unanimously.
