CALL MEETING TO ORDER

Mayor Qourzal called the meeting to order at 5:31 p.m.

Dr. Oubre asked Mr. Norman (Assistant Director of Community Services and Development) to provide Ms. Bartels with his business card so they can discuss the status of the project.
 - Mike Barron, resident He expressed frustration over the sewer project and dealing with the noise of

Asked what the plans for restoration of trees after the project is complete. Dr. Oubre stated that Mr. Norman will reach out to him and discuss whatever the restoration plans are.

They are asking the City to partner with Woodway Elementary and the PTA in helping them fund and update some of the basic necessities needed for park safety and outdoor recreation at the PAW.
