7. A. DISCUSSION AND CONSIDER ACTION ON ORDINANCE 24-07, ADOPTING THE 2024-2025 ANNUAL BUDGET

Mr. Niolet presented this item.

Chief El-Halabi provided comments on salaries and recruitment in his department. Sergeant Brummett provided additional comments.

Councilmember Gilman moved to adopt Ordinance 24-07, adopting the City of Woodway 2024-2025 Annual Budget. Mayor Pro Tem Williams seconded, and Mayor Qourzal read aloud the caption of the ordinance as required. Voting in favor: Qourzal, Williams, Russell, Cook, Gilman, Keyston and Sury. The motion passed unanimously.

B. DISCUSSION AND CONSIDER ACTION ON RATIFICATION OF THE PROPERTY TAX REVENUE INCREASE REFLECTED IN THE BUDGET

Councilmember Gilman moved to ratify (approve) the property tax revenue increase reflected in the budget. Mayor Pro Tem Williams seconded. Voting in favor: Qourzal, Williams, Russell, Cook, Gilman, Keyston and Sury. The motion passed unanimously.

8. PUBLIC HEARING ON PROPOSED 2024 AD VALOREM TAX RATE

Mayor Qourzal opened the public hearing.

Councilmember Keyston moved that the property tax rate be increased by the adoption of a tax rate of 0.357865, which is effectively a 2.13 percent increase in the tax rate." Councilmember Cook seconded, and Mayor Qourzal read aloud the caption of the ordinance as required. Voting in favor: Qourzal, Williams, Russell, Cook, Gilman, Keyston and Sury. The motion passed unanimously.

- Our Assistant City Manager, Jennifer Rogers along with the Arboretum and Pavilion staff have collaborated and put out a survey on social media to receive citizen and visitor input for what kind of programming they want to see offered at the Carleen Bright Arboretum and The Pavilion.
- Micro-seal project for this year's streets are complete.
- Looking forward, as we continue discussion on the water loss, Brenda helped put together a percentage loss list from 2000 through this year. The average based on the gallons we pumped and purchased from Waco versus what we sold, there is an average of 19% loss. This year is a 25% loss.
