Assistant City Manager Rogers provided the following:

- Update on the Estates Drive Shared Path For the last few weeks, the contractor striped the new lane configuration to specification with work continuing on lane markings and curbing. Since the work began, motorists have been adjusting to the new traffic pattern with the guidance of our public safety officers. Cyclists and pedestrians are already using the new lane. Once the barricade has been installed, it will better indicate the separation between the shared path and the traffic lanes. Staff are monitoring citizen concerns to be addressed before project completion and the City anticipates finishing this project in three weeks, with close-out occurring before Christmas with weather permitting.
- Discover Woodway and City of Woodway staff hosted another Veterans Breakfast on Thursday, November 7th.
- Senior Programming Survey The Woodway Family Center Staff created a survey for their current and future senior programming. This survey opened on November 4th and closed on November 18th. They collected 94 responses and since it just closed today, staff are going over those results.
- The Discover Woodway staff will launch a survey in early January pertaining to all the City events we host throughout the year.
