Councilmember Russell moved to approve the minutes of the regular City Council meeting held October 23, 2023 at 5:30 p.m. Councilmember Cook seconded and the motion passed unanimously.

Dr. Oubre presented this item regarding casting votes to elect directors for the McLennan Central Appraisal District.

Mayor Qourzal moved to adopt Resolution R-23-19 casting 20 votes for Jonathan Green, 21 votes for Dwain Moss and 20 votes for Ben Perry for directors of the McLennan Central Appraisal District for the year 2024. Mayor Pro Tem Williams seconded and the motion passed unanimously.

4. DISCUSSION AND CONSIDER ACTION ON ENTERING INTO AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF WOODWAY AND MCLENNAN COUNTY FOR THE WORK AND MATERIALS TO CHIP SEAL PARK I ROAD, LOCATED IN THE CITY OF WOODWAY, IN AN AMOUNT NOT TO EXCEED \$67,831.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN CONNECTION THEREWITH

Dr. Oubre presented this item. This is a joint effort between the City and the County.

Councilmember Keyston moved to approve entering in an Interlocal Agreement between the City of Woodway and McLennan County, to provide work and materials to chip seal Park I Road, located in the City of Woodway, in an amount not to exceed \$67,831.00 and authorizing the City Manager to execute all documents in connection therewith. Councilmember Gilman seconded and the motion passed unanimously.

5. DISCUSSION AND CONSIDER ACTION ON ENTERING INTO AN AGREEMENT WITH WALKER PARTNERS LLC, TO PROVIDE ENGINEERING SERVICES IN CONNECTION WITH THE WOOD VALLEY DRIVE PARKING LOT PROJECT IN AN AMOUNT NOT TO EXCEED \$38,500.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN CONNECTION THEREWITH

Dr. Oubre presented this item. Kyle Schulze with Walker Partners provided additional information and answered questions.

Councilmember Cook moved to approve entering into an agreement with Walker Partners, L.L.C., to provide engineering services in connection with the Wood Valley Drive Parking Lot Project in an amount not to exceed \$38,500.00, and authorizing the City Manager to execute all documents in connection therewith. Councilmember Gilman seconded and the motion passed unanimously.

6. DISCUSSION AND CONSIDER ACTION ON ENTERING INTO AN AGREEMENT WITH MRB GROUP, PC, TO PROVIDE PROFESSIONAL SERVICES IN CONNECTION WITH THE ESTATES DRIVE AND FAIRWAY ROAD BICYCLE AND PEDESTRIAN CONNECTIONS PROJECT IN AN AMOUNT NOT TO EXCEED \$49,650.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN CONNECTION THEREWITH

Dr. Oubre presented this item. Solomon Thomas with MRB Group provided additional information and answered questions.

Councilmember Cook moved to approve entering into an agreement with MRB Group, P.C., to provide engineering services in connection with the Estates Drive and Fairway Road Bicycle and Pedestrian Connections project in an amount not to exceed \$49,650.00 and authorizing the City Manager to execute all documents in connection therewith. Councilmember Gilman seconded and the motion passed unanimously.

7. DISCUSSION AND CONSIDER ACTION AUTHORIZING A CHANGE ORDER FOR AN AMOUNT NOT TO EXCEED \$65,035.53 TO AN EXISTING CONTRACT WITH JOHN W. ERWIN GENERAL CONTRACTOR, INC., FOR THE NEW WOODWAY FAMILY CENTER TO ADD ADDITIONAL HANDICAPPED PARKING SPACES, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN CONNECTION THEREWITH

Dr. Oubre presented this item. Dr. Oubre and Jimmy Rogers, Woodway Family Center Superintendent answered questions.

Councilmember Cook moved authorize a change order for an amount not to exceed \$65,035.53 to an existing contract with John W. Erwin General Contractor, Inc., for the new Woodway Family Center to add additional handicapped parking spaces, and authorizing the City Manager to execute all documents in connection therewith. Councilmember Gilman seconded and the motion passed unanimously.

8. DISCUSSION AND UPDATE ON THE NEW WOODWAY FAMILY CENTER CONSTRUCTION TIMELINE (FINAL INSPECTION, WALKTHROUGH, TEXAS ACCESSIBILITY STANDARDS "TAS" AND PARKING LOT IMPROVEMENTS)

Mr. Adam Niolet, Assistant City Manager, provided an update on the new Woodway Family Center construction timeline and a possible new opening date being end of February 2024.
