5. PRESENTATION ON RETIRING K-9 SHAKA FROM WOODWAY PUBLIC SAFETY DEPARTMENT

Chief El-Halabi provided that K-9 Shaka has assisted with 325 total searches and is known in this area as a very reliable K-9 and "Pride of Woodway." Corporal Hilliard spoke about his K-9 partner and stated that they have been together for about seven (7) years.

Mayor Qourzal presented K-9 Shaka and Corporal Hilliard with a plaque in recognition of her service to the City of Woodway.

Representative services for the Fairway Gravity Sewer Replacement Phase III, in an amount not to exceed \$170,000.00, and authorizing the City Manager to execute any documents in connection therewith. Mayor Pro Tem Williams seconded and the motion passed unanimously.

8. DISCUSSION AND CONSIDER ACTION TO REQUEST AND/OR RECEIVE ADDITIONAL INFORMATION OR CLARIFICATIONS FROM KSA ENGINEERS, INC. AND/OR TERRACON, PROVIDERS OF PROFESSIONAL SERVICES WHO RESPONDED TO RFP #24-01 FOR THE FACILITY CONDITION AND ASSESSMENT AND COST ANALYSIS ON THE OLD WOODWAY FAMILY CENTER.

The second interview was with KSA. John Selmer provided an overview on a PowerPoint presentation and answered questions.
