WHAT IS THE VOLUNTEERS IN POLICE SERVICE PROGRAM?

The Volunteers in Police Service (VIPS) Program is a national program which provides support and resources for law enforcement agencies interested in developing or enhancing a volunteer program and for community members who wish to volunteer their time and skills with a community law enforcement agency. Local VIPS programs offer direct volunteer opportunities and conduct their own screening, recruitment, and placement.

How Do I Start?

If you are interested in serving your community by volunteering with a law enforcement agency, you can search the directory on the VIPS Web site www.policevolunteers.org to find a local VIPS program near you. If there is not a program listed near you, contact your state or local law enforcement agency to find out if they have a volunteer program.

What Are The Requirements?

Application requirements will differ from program to program. Most law enforcement volunteer programs will require a background check. There may also be requirements based on age, background and availability. You should check with the agency's volunteer coordinator to find out any special qualifications.

THE PRESIDENT'S VOLUNTEER SERVICE AWARD

The President's Council on Service and Civic Participation created the President's Volunteer Service Award program as a way to thank and honor Americans who, by their demonstrated commitment and example, inspire others to engage in volunteer service. The program recognizes individuals, families, and groups that have achieved a certain number of volunteer hours served over a 12-month period or cumulative hours earned over the course of a lifetime. Adults can begin earning an award at 100 hours of service. Individuals can earn the President's Call to Service Award once they have provided 4,000 hours of service over the course of their lifetime.

Award recipients receive an official President's Volunteer Service Award pin, a personalized certificate of achievement, a note of congratulations from the President of the United States, and a letter from the President's Council on Service and Civic Participation. Many local VIPS programs participate in the President's Volunteer Service Award program.
